



## **BUCKLE DOWN STUDENT CONTRACT**

I understand that proper use of seatbelts saves lives and that my actions to always wear my seatbelt and to encourage others to do so as well may prevent deaths or injuries resulting from motor vehicle crashes. I also understand that the consumption of alcohol, illegal drugs, and/or some medications will cause impairment of judgment and actions that will render the operation of a motor vehicle unsafe.

I understand that, as a student in grades 9-12, I may participate in the Buckle Down program. By signing this contract, I hereby acknowledge that I am in agreement with all terms and conditions of this contract. I understand that I must comply with all terms of the contract and that I must have a valid Indiana Learner Permit or Driver's License by March 1, 2010, to be eligible for the grand prize drawing that will be held at the end of the 2009-2010 school year.

In addition to the conditions set forth above, I further agree to abide by all of the following terms:

1. I will wear my seatbelt at all times while operating or riding as a passenger in a motor vehicle as is required by law.
2. I will operate a motor vehicle only when all passengers are properly restrained by a seatbelt or child passenger safety seat as is required by Indiana law.
3. I will not consume any alcohol.
4. I will not consume any illegal drugs or abuse prescription drugs.
5. I will not use any type of telecommunication device while driving a vehicle except for making emergency 911 calls as is required by the new Graduated Driver's License Law.
6. During the contract period of 11/1/09-5/1/09:
  - I will abide by all Indiana traffic laws and will not be arrested for any traffic offenses.
  - I will not be arrested for any alcohol or drug related offenses.
  - I will not be arrested for any seatbelt violation.
  - I will remain in good standing as a student at my high school and follow all school rules and policies.
  - I understand that law enforcement officers and/or school officials can monitor my compliance with the above listed rules throughout the duration of the Buckle Down program. If it is determined that I have not been in complete compliance; I understand that I will not be eligible to win any prizes associated with Buckle Down.
7. I will complete a pre program survey at the time I sign the contract and a post program survey by March 20, 2010. I understand I must complete both surveys and submit a complete Student Contract to be eligible for the grand prize drawing.
8. I understand that I am solely responsible to pay all applicable income taxes on any prize that I may win during the Buckle Down prize drawing.
9. If I am the winner of the grand prize drawing for an automobile, I am solely responsible to ensure that I register and title that vehicle in my name or in my parents' name, that I must provide proper insurance for that vehicle, and that I must pay all applicable fees on the vehicle.
